HEREBY:

1. Acknowledge that a horse may, without warning or any apparent cause, buck, stumble, fall, rear, bite, kick, run, make unpredictable movements, spook, jump obstacles, step on a person's feet, push or shove a person, saddles or bridles may loosen or break – all of which may cause the

rider to fall or be jolted, resulting in serious injury or death.

- 2. Acknowledge that horseback riding is a dangerous activity and involves RISKS that may cause SERIOUS INJURY AND IN SOME CASES DEATH, because of the unpredictable nature and irrational behavior of horses, regardless of their training and past performance.
- 3. Voluntarily assume the risk and danger of injury or death inherent in the use of the horse, equipment and gear provided to me by Nancy Volkoff.
- 4. RELEASE, DISCHARGE AND PROMISE NOT TO SUE Nancy Volkoff and/or any of her employees and agents (hereinafter the "Releasees"), for any loss, liability, damage, or cost whatsoever arising out of or related to any loss, damage, or injury (including death) to my person or property.
- 5. Release the Releasees from any claim that such Releasees are or may be negligent in connection with my riding experience or ability including but not limited to training or selecting horses, maintenance, care, fit or adjustment of saddles or bridles, instruction on riding skills or leading and supervising riders.
- 6. INDEMINFY, AND SAVE AND HOLD HARMLESS Nancy Volkoff and her employees and agents from and against any loss, liability, damage or cost they may incur arising out of or in any way connected with either my use of the horse and any equipment or gear provided therewith or many acts or omissions of wranglers or other employees or agents.
- 7. Agree to abide by and follow any instructions given or rules established by her or any of her employees, guides or wranglers with regard to my use of the horse or any equipment or gear provided therewith.

- 8. The Undersigned expressly agrees that the foregoing release and waiver of liability, assumption of risk, and indemnity agreement is governed by the State of California and is intended to be as broad and inclusive as is permitted by California law, and that in the event any portion of this Agreement is determined to be invalid, illegal, or unenforceable, the validity, legality and enforceability of the balance of the Agreement shall not be affected or impaired in any way and shall continue in full legal force and effect.
- 9. Acknowledge that this document is a contract and agree that if a lawsuit is filed against Nancy Volkoff or her agents, employees, guides or wranglers for any injury or damage in breach of this contract, the Undersigned will pay all attorney's fees and costs incurred by Nancy Volkoff in defending such an action.
